

## Privacy Policy & Legal

This Privacy Policy ("Policy") outlines the information RYL, LLC collects from visitors to our websites in an effort to support and further our relationship with you, including providing you with requested information and/or products or services. We do not sell or rent your personal information.

This Policy also describes the personal information we may collect about you, how we may use and disclose that information and the choices you can make about how we collect and use your information. ### **What kind of information does RYL, LLC collect?**

#### **Technical Information:**

RYL, LLC utilizes third-party tracking applications to measure and analyze site traffic. These applications may collect information such as your computer's operating system and browser type, IP address, address of a referring website, if any, etc. and may track a user's path through our websites.

#### **Personal Information:**

Except as set forth in this Policy, RYL, LLC will not through its website collect, store or release any personal identifying information about you without first receiving your consent.
